All board members are now responsible to get the results after the pull. They in turn will get it to Kathy. The board is also responsible to get the check from the organization holding the pull. Once the check is received, Kathy will be told by a board member to write out the checks. Kathy will then either send out the checks or hold them until the following weekend if she will be at a pull. #### NEW RULE CHANGES FOR 2010 PULLING SEASON.

#### Membership Section

1. Page 3 #8 #9 #10 #11 Change: one time fee \$75 allowed

2wd \_\$50 SF\_\$100 NSS\_\$25 Semi\_\$30 SA\_\$30 HF\_Must Join

#### **General Section**

1. Page 5 #12 Addition: Pull order

You must hook in order of registration to qualify for points and money. If you legitimately break prior to hooking, you will be allowed to repair and still compete as long as you come into line as soon as repairs are done and class is still pulling. 2010

2. Page 6 #13 Addition: Late to show

If arriving late to the show, no competitor may compete in his/her class if the class has already started and vehicle was not pre- registered.. 2010

3. Page 8 #32 Change: Protest fee

If a PI member of the same class wants to protest, the protester puts up \$500.00 and the vehicle being protested puts up \$500 before being tested. The total protest fee of \$1000 is split between the protested and Puller's Inc if not found guilty. If found guilty, the \$1000 is split between the protester and Puller's Inc. 2010

4. Page 8 #36 Change: stock semi

SEMA approved helmets and fire jacket must be on before vehicle reaches the track and stay on until their pull is done.

Except for Semi STOCK Trucks, they only need a fire jacket. 2010

## Super Stock Trucks

1. Page 16 Hitch #6 change

Hold up mounting pin or pivot point on bottom side of pulling hitch must be no more than a maximum of six inches from hook point. 2010

1 Page 17 Engine #15 delete

One year trial base, Rich Calenzo may run a limited C.I. blower motor along with the naturally aspirated mod 4 X 4 trucks.

No points / no money. 2009

2 Page 19 Engine add Blown Engine rules

2 different types of engine: Naturally Aspirated Engine and Blown Engine.2010

# Two-wheel Drive (2 WD)

1 Page 24 Engine #1 addition

A non-competitive tech to tag seal motors and hold onto tool for this job. 2010

# Street Altered Trucks

1 Page 27 Body #6 change

Truck must have fully functional front brake system or driveline brake. 2010

2 Page 27 Body #8 addition

Allow light weight hoods with up to 4" hood scoop. 2010

3 Page 28 Drive Train #3 Change

One transmission/one transfer case allowed, all components must be stock appearing. After market gears allowed. 2010

4 Page 28 Drive Train #4 addition

All driveline brakes must be shielded 360 degrees around it with 1/8" steel or 1/4" aluminum. The caliper may be used as part

of the shield. Drive shaft loops, scatter shields, scatter blanket are HIGHLY recommended. 2010

1. Page 33 Engine #7 addition

855 Cubic inch limit to take effect in pulling year 2011. 2010

# **Hot Farm Tractors**

1. Page 34 Engine #3 change

 $3000\ \text{RPM}$  with no more than one- one second- spike when hooked to sled. 2010

2. Page 34 Engine #6 change

Water injection is allowed with lubricants. 2010

3. Page 34 Engine #11 change

No removable slugs allowed on inlet side of turbo charger. 2010

4. Page 35 Engine #14 remove

Turbo must be 3LM or T04 or equivalent.

5. Page 35 Engine #14 addition

No pre cooling of air is allowed before the turbo. 2010

6. Page 35 Engine #20 addition

Tractor must be teched for cubic inch and pan bolts must be sealed by second hook of tractor per year. 2010

## Semi Trucks

1. Page 36 Engine #5 RPM rule

Must run stock RPM. 2010

1. Page 37 Title add Open Semi Class

Open Semi Class. 2010

Open Semi Class must also follow the following rules.

- 1 Drive shaft must be shielded 360 degrees around with 5/16" steel.
- 2 Flywheel and clutch protection blanket or  $\frac{1}{4}$ " thick steel to cover bell housing.
- 3 Vehicle must be equipped with an air shut off switch devise on rear of truck.
- 4 Engine shields 360 degrees around harmonic balancer.
- 5 Engine driven fan must have shroud 360 degrees around fan, no steel blades allowed.
- 6 Water injection allowed.
- 7 Fire Jacket and helmet required.
