#### Membership Section

1. Page 2 #6 Addition

All board members allowed one vehicle membership only at no cost plus \$50 for insurance.

2. Page 3 #2 Addition


Onetime hook fee is defined as per vehicle, not driver. 2011

3. Page 3 #8 Change Semi only Or they may pay a one time hook fee of \$50. 2011

## General Rules Section

1. Page 10 #58 Addition

Suggestion only: Draw bar steel hitching devise to be tear drop shaped of 3-3/4" long x 3" width with a max of 3-3/4" round.

1. Page 18 Engine #7 Change

Allow for use of 481 CI motor with OEM cast iron, single 1050 Dominator max with no modification, with single plate style nitrous style and orifice size to be determined on a one year trial basis.2011

## Street Altered Trucks changed to Open Stock 4X4 Trucks

1. Page 20 Engine #3 Addition

Engine block must be same as truck manufacture.

2. Page 21 Weight #1 Addition

6200 pound max weight limit.

3. Page 21 Weight #3 Addition

Only thing to extend past front bumper is weight and weight bar. Any functional component of truck can not be used as weight. 2011

Power Programmer to OEM-ECM allowed.

2. Page 28 Engine #4 Addition

No power box allowed (Such as a Pittsburg power box)

## Street Open Semi

1. Page 29 Hitch #1 addition

Hitch height 18 inches.

2. Page 29 Engine #5 Addition

Limit fuel system to p-pump set up or cyclone parts.

3. Page 29 Engine #6 Addition

Turbo size limited to 4.1

4. Entry fee \$50.00 per hook
