## 2012 PULLING SEASON RULE CHANGES

### Membership Section

1. Page 2 #6 Addition  
There will be 12 members on the Board of Directors.
2. Page 3 #7 Deletion  
Or they may pay a onetime per vehicle fee of \$50.00
3. Page 3 #8 Deletion  
Or they may pay a onetime per vehicle fee of \$30.00
4. Page 3 #9 Deletion  
Or pay a \$100.00 fee per pull.2010
5. Page 3 #14 Addition  
A non-member may pull in its designated class, following tech inspection, for exhibition only.  
No points or money. A \$30.00 fee to be paid at registration. Exhibition pullers will draw numbers and pull in order of class. ( Except Natural Super Stock Tractors). 2012

### General Rules Section

1. No changes

### Super Stock Trucks

1. Page 10 #3 Body Changes  
Any hood scoop allowed.
2. Page 10 #2 Engine Changes  
Engine and truck must be made by the same manufacturer, heads must be factory production type heads with stock type valve train available. Except Fords A460 type cylinder heads allowed. No C460 type cylinder heads. 2012

### Mod 4X4 Trucks

3. No changes

### 2 Wheel Drive Trucks

1. Page 18 #7 Engine Renewal  
Allow for use of 481 CI motor with OEM cast iron, single 1050 Dominator max with no modification, with single plate style nitrous style and orifice size to be determined on a one year trial basis. 2012

### Open Stock 4X4 Trucks

1. Page 20 #1 Engine Addition  
Trucks must contain factory stock engine with 480 CI limit with 2 CI leeway. Engine naturally aspirated- no alcohol- no N.O.S 2012
2. Page 20 #10 Engine Addition  
Dry sump oil system allowed.
3. Page 20 #2 Drive Addition  
Multiple shocks are allowed. Lower front shock mount must be within 6" of the center of front axle.

### Super Farm Tractors

1. Page 22 #3 Engine Removal  
One year trial base in PPL intake manifold rule.
2. Page 23 #1 Weight Removal  
Rule effective through 2011.

### Natural Super Stock Tractors

1. No change

### Hot Farm Tractors

1. Page 26 #6 Addition  
Water injection is allowed with lubricant. Random water sample will be checked. Illegal water is grounds for disqualification. Tractors required to add a drain valve or petcock to take a test water sample from the water injection system. Have the valve teed into the same line that feed the water injection pump. If the valve is mounted in a remote location with a hose or line, be able to show tech official the line came from the same line that feeds the pump. 2012
2. Page 27 #1 Year Change  
20.8 tires are limit- no cut tires or altered tires. 2012

1. Page 29 #2 Addition  
Blocked suspension allowed. 2012
