Each person must fill out an application. **All members must have a signed application on record before they pull or they will be disqualified.** Must be 18 years of age to drive, or 16 years of age with parental consent. **2 Wheel Drive Truck Pullers**: If your truck is ready to teched, please call Paul Flynn. He will arrange with you a time prior to the pulling season for an inspection.

**Open Stock Truck Pullers**: If your truck is ready to teched, please call Shawn Hadel. He will arrange with you a time prior to the pulling season for an inspection.

### 2013 PULLING SEASON RULE CHANGES

Membership Section

1. Page 3 NSS#8 Change

Or they may pay a \$30.00 hook fee for money, but no points.

General Rules Section, Super Stock Trucks, Mod 4X4 Trucks, Super Farm Tractors

1. No changes

2 Wheel Drive Trucks

1. Page 18 #7 Engine Renewal

Allow for use of 481 CI motor with OEM cast iron heads, single 1050 Dominator max with no modification, with single plate style nitrous style and orifice size to be determined on a one year trial basis.2013

Open Stock 4X4 Trucks

1. Page 20 #2 Body Change

Traction bars allowed on front and rear. 2013

- Page 20 #2 Drive Addition Multiple shocks are allowed. Lower front shock mounts must be mounted within 6 inches of the center of front axle. 2012
- Page 21 #6 HitchRemove Hold up mounting on bottom side of pulling hitch must be no more then a maximum of six inches from hook point.

4. Page 21 #6 Hitch Addition

The support point of pulling hitch must be no more than a maximum of 6" from hook point. Top or bottom hitch support. 2013

Natural Super Stock Tractors

- Page 24 #8 Engine Addition
   "Turbo Diesel Tractors" allow maximum of 466 CI diesel engine to run 2.31 turbo charger. Wheel must protrude
   in, no slugs or stops in housing or wheel are allowed. A map ring permitted in stock location not to exceed .250"
   One year trial base. 2013
- Page 24 #9 Engine Addition No inner coolers allowed. One year trial base. 2013
   Page 24 #10 Engine Addition
- Page 24 #10 Engine Addition A fuel shut off is required and must be located after fuel filter. The shut off to be operated by tractor driver or sled operator. One year trial base. 2013
- 4. Page 25 #1 Weight Addition Weight for Gas fueled tractors is 6800 # max weight Weight for Diesel fueled carbureted tractors is 6500 # max weight 300 pound variance given on only gasoline fueled carbureted tractors. Subject to fuel testing at tech official discretion. 2013

Hot Farm Tractors

- 1. Page 26 #6 Body Deletion
- No rack and pinion steering. 2013 2. Page 26 #7 Body Deletion
  - No tube frames. 2013
- 3. Page 26 #8 Body Addition
  - Rops with seat belt required. Roll cage with 5 point harness recommended. 2013
- 4. Page 26 #11 Engine Combine/Addition
  - Only one turbo charger allowed. Inlet side **up to 2.75" can be slotted and over 2.75 up to 3" max must be smooth bore. No slots or map rings.** No removable slugs allowed on inlet side of turbo charger. Intake wheel must protrude into housing. No exposed turbo chargers. No big foots. Exhaust bolt pattern on larger than 2.70" x 3.5", or 69mm x 88mm. No altering of a housing to accommodate a smaller base. Turbo size will be checked once a year and may be spot checked at any pull during the year. 2013

Street Stock Semi Trucks

1. No changes

Street Open SemiName Change "Outlaw Stock Semi" One year trial Bases.

- 1. Page29 #1 Body Addition Certified clutch or safety blanket if running over 2300 RPM's. Stock RPM's, no blanket required.
- 2. Page 29 #2 Body Addition Stock working suspension.
- 3. Page 29 #1 Engine Addition OEM motor and fuel system
- 4. Page 29 #2 Engine Addition No water injection except for Al Mcdowell.
- Page 29 #3 Engine Addition Air shut off required if over 2800 RPM on rear of truck. Over 2800 RPM, all safety equipment must be in place. Knuckles, guards, harmonic balancer -loops where needed.
- 6. Page 29 #4 Engine Addition Turbo charger limited to 4.1 (Twin turbo legal if it came stock on motor)
- 7. Page 29 #1 Hitch Addition Hitch height at 24"
- 8. Page 29 #1 Tires Addition DOT tires only
- 9. Page 29 #1 Weight Addition Max weight 20,000
- 10. Page 29 #1 Misc Addition Fire Jacket required while pulling.
